# Replacement Program Information

## REQUIREMENTS FOR VEHICLE OWNER:

- The vehicle owner name(s) listed on the application must be the same name(s) listed on the registration and title of the vehicle.
- Income can be verified using the **most recent year's**: Federal Income Tax 1040 Form (use Adjusted Gross Income); W2; Disability or Social Security documents; pay stubs for the last three months; or a signed, handwritten statement of unemployment (statement must include details on whether or not any assistance or benefits are/were received by the unemployed individual(s)). If an individual receives federal assistance, a benefits letter may be submitted as income verification.

## REQUIREMENTS OF VEHICLE:

- Vehicle must be currently registered, as well as registered for 12 of the past 15 months, in a participating county prior to the application date. The counties currently participating in the program are: Collin; Dallas; Denton; Ellis; Johnson; Kaufman; Parker; Rockwall; and Tarrant
- Vehicle must be 10 years old or older and have passed a Texas Department of Public Safety (DPS) safety and emissions inspection within 15 months of the application date.
- If the vehicle is newer than 10 years old, it must have failed an emissions inspection within the past 30 days of the application date and a passing safety and emissions inspection within 15 months of the application date.
- Vehicle must be drivable and gasoline powered.
- Commercial and fleet vehicles are not eligible for assistance.
- No reimbursements are allowed if: the vehicle purchase is made prior to receiving a valid voucher letter; or if the vehicle is purchased at a non-participating dealership.

## IF ALL REQUIREMENTS ARE MET, THE FOLLOWING REPLACEMENT ASSISTANCE IS AVAILABLE:

- \$3,000 toward an eligible\* car (includes SUVs and minivans) that is 3 years old or newer; or
- \$3,000 toward an eligible\* truck that is 2 years old or newer; or
- \$3,500 toward an eligible\* hybrid, electric, natural gas, or Tier 2 Bin 3 or cleaner vehicle that is 3 years old or newer.

*\*Based on the EPA's Federal Tier 2 Bin 5 or cleaner emissions standard. Visit our website for a list of eligible vehicles.*
